

RESOLUTION NO. 2003-854

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CALABASAS, CALIFORNIA, AMENDING THE CABLE SYSTEM FRANCHISE AGREEMENT GRANTING A FRANCHISE TO ADELPHIA CALIFORNIA CABLEVISION, INC. TO EXTEND THE TERM OF SAID FRANCHISE UNTIL DECEMBER 1, 2015.

WHEREAS, the City Council of the City of Calabasas adopted Resolution No. 99-568, approving a cable system franchise agreement between the City of Calabasas and Calavision, Inc. and granting a renewal of the cable system franchise for the Calabasas Park area for a 12-year period; and

WHEREAS, the City Council of the City of Calabasas adopted Resolution No. 99-595 approving the transfer of the cable television franchise from Calavision, Inc. to Adelphia California Cablevision, Inc.; and

WHEREAS, the Adelphia, Saratoga Hills franchise will expire on December 1, 2015 and the City desires to have the two franchises terms run concurrently; and

WHEREAS, Adelphia has agreed to extend this franchise agreement with the City until December 1, 2015; and

WHEREAS, the existing agreement contains terms and conditions that are reasonable to meet the community needs and interests, taking into account the cost of meeting those needs and interests.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CALABASAS DOES ORDAIN AS FOLLOWS:


Section 1. The City hereby amends Adelphia, Calabasas Park franchise Resolution No. 99-568 (as amended) by providing an extension, changing the Resolution termination date from July 16, 2011 to December 1, 2015, during which period the City shall retain all oversight and enforcement rights. Said extension shall not impair the rights of the City to revise its cable television regulations pursuant to the City's authority.



Section 3. The City Clerk shall certify to the passage and adoption of this resolution and shall cause the same to be published according to law.


